# State Health Plan Data (SHP)

## The State Health Plan Data is part of the Carolina Cost and Quality Initiative (CCQI)

The *Carolina Cost and Quality Initiative* is a collaborative partnership between UNC's School of Public Health and the Cecil G. Sheps Center for Health Services Research to build, maintain and oversee the use of data for research. Periodic updates from the payers keep the research database current and relevant.

The mission of the *Carolina Cost and Quality Initiative* is to promote population based research on the incidence and prevalence of disease in insured populations, patterns of utilization, treatment and cost of care in North Carolina with an objective to improve the delivery and quality of care to its residents.

#### **Database Description**

Claims data from BCBSNC for the State Health Plan. Data includes inpatient, outpatient, professional, member, and pharmacy data.

Data currently available: January 1, 2001 - December 31, 2012

-Claims through December 2011 are final adjudicated claims

-Claims from January-December 2012 are provisional claims


-Claims are included based on date of admission or date of service







# Data Access Guidelines

#### Who can use the data?

**Researchers at the University of North Carolina at Chapel Hill can apply to use the State Health Plan Claims Dataset.** Project proposals must be submitted to a review committee for prior approval in order to assure the feasibility of the proposed research using these specialized datasets. Guidelines for project submission are available in the Requests for Analytic Data section below.

## **Cost of data**

(Updated 9.11.15) Preliminary data management and programming costs to prepare research files tailored to each individual researcher's project, and to assist the researcher in learning how to use the data are covered internally. There are no fees for initial consultations or for creation of basic analytic data sets of reasonable size. It is anticipated that these basic services will take up to 10 hours (2 hours of analytic consultation and 8 hours of analytic time). There may be costs to the researcher for data management and programming work beyond the preliminary support mentioned above. The cost to the researcher will be estimated based on a needs assessment using an hourly rate of \$65/hour. Funded projects will be asked to pay for all analytic costs, and we recommend including sufficient funding for analytic time in all proposals where work on the SHP data is included. Funding to pay for data management and programming time must be arranged and documented before the data request is submitted.

#### **Data Access Guidelines: Preliminary Data Requests**

Requests for preliminary data for grant submissions or planning purposes, can be submitted by email to the contact information listed below. Include a paragraph describing your project and what information is needed. Preliminary information is limited to counts and basic descriptive statistics.

#### Data Access Guidelines: Requests for Analytic Data

Researchers at UNC may submit a **State Health Plan data request form** to the CCQI Oversight Committee to use these specialized data sets. The Oversight Committee includes researchers from the Sheps Center, and staff at the State Health Plan. The full approval process can take several months, depending on whether revisions are required.

We recommend a phone consult prior to submitting your data request. Please see the <u>contact information</u> section for phone numbers.

## **Review Criteria**

Criteria used by the Oversight Committee, to evaluate each request, are described briefly below:

- 1. Is the research question one that is in keeping with the overall focus of Initiative and important to be answered, for North Carolinians or to the US health system as a whole, either from a policy or practice perspective?
- 2. Can the research question be adequately answered using the requested database? Are there an adequate number of cases to be studied for the proposed analysis? Are the right data elements available and specified? For the key data elements needed, is the quality of the data adequate?
- 3. Is the proposed methodology sound and viable with respect to the research questions, population and data requested?
- 4. Does the research team possess the requisite skills/experience and proposed resources to conduct the research with high standards and in an adequately specified time frame?

**State Health Plan WAIVER OF HIPAA AUTHORIZATION** (only for those who receive an IRB Waiver of HIPAA Authorization)

Provide copy of IRB approval letter on letterhead (from IRBIS)

**<u>State Health Plan DUA for Researcher</u>** – Must be executed before request can be submitted for approval to the State Health Plan.

## **Researcher Responsibilities**

Funding acknowledgement should be included in all journal articles or conference abstracts:

**Funding Acknowledgement:** The database infrastructure used for this project was funded by the Department of Health Policy and Management, UNC Gillings School of Global Public Health; the CER Strategic Initiative of UNC's Clinical Translational Science Award (UL1TR001111); and the UNC School of Medicine.

Data Use Agreements must be kept up to date. All staff and researchers with access to the data set must sign the DUA.

As described in the Data Use Agreement all journal articles and abstracts must be submitted to the Sheps Center for review by the State Health Plan. *"The User agrees that a preliminary copy of the findings will be shared with the Recipient and Covered Component one month prior to submission for publication. Abstract submissions must also be shared at least five business days prior to submission."*
